Purpose

As outlined in the school's Child Protection (Safeguarding) policy, there is a prescribed process to follow in the event of an allegation of abuse.

- 1. It is essential that the high standards of concern and professional responsibility adopted with regard to alleged child abuse by parents are similarly displayed when members of staff are accused of abuse.
- 2. The procedure to be followed in the event of an allegation being made against a member of staff is set out in Berkshire Child Protection Procedures. This must be accessed online at https://proceduresonline.com/berks/west_berk/p_alleg_against_staff.html

- 3. Through discussion and consultation, a decision will be made whether to hold an Allegation Against Staff and Volunteers' Meeting. Where the allegation is against the headteacher, the Chair of Governors will take this action.
- 4. If for any reason it is decided that an Allegation Against Staff and Volunteers' Meeting is not appropriate, it may be necessary to address matters in accordance with the school's disciplinary procedures in liaison with the school's HR Adviser.
- 5. Staff and volunteers as part of their induction are provided with a guide for staff faced with an allegation of abuse.
- 6. This policy will be monitored by the Headteacher and full Governing Board, and reviewed every three years.
