Part A: Pupil premium strategy plan

Statement of intent

"I have come that they may have life and that they may have it more abundantly." John 10.10
At Theale CE Primary School, we believe that children come first. We believe in striving for the best education for all children and for all children to have equal access to an excellent learning experience. We aim to ensure that no children should be disadvantaged educationally, irrespective of their background or the disadvantages they face. All children should leave Theale CE Primary equipped with the skills, confidence, resilience and determination needed to succeed in the future. We know that some learners may need greater support to achieve their full potential, which we strive to provide on an individualised, personal basis. Equity is fundamental in our school culture, and we tailor the support for each pupil's individual circumstances to ensure effective access to outstanding education. The Pupil Premium Lead ensures the visibility of pupils in receipt of PPG, and all class teachers work to ensure their educational achievement and wellbeing. We undertake effective tracking and assessment throughout the academic year which allows us to put effective support and interventions in place as required. The tracking of pupils involves formalised assessment, teacher meetings and pupil voice activities. Finally, we strive to raise the profile of pupils in receipt of PPG by enabling them agency within their schooling.

We will

- . Adopt a whole-school approach in which all staff take responsibility for the outcomes of pupils in receipt of PPG with specific PP staff meetings and targeted data-tracking
- . Have the highest aspirations and expectations for all of our pupils, including those who are already high-attaining
- . Strive for excellence and celebrate success
- . Build positive relationships with the children and their families
- . Ensure that all teaching and learning meets the needs of all of the pupils (evidence shows that this is imperative for all children)
- . Make appropriate provision for pupils who belong to vulnerable groups, this includes ensuring that the needs of all pupils are adequately addressed, such as in attendance and behaviour
- . Track pupil progress carefully, ensuring that specific provision is in place for all pupils whose circumstances may be considered 'disadvantaged' pupils
- . Recognise that not all pupils who are experiencing disadvantage are registered or qualify for free school meals. We therefore allocate pupil premium funding to support any pupil or groups of pupils that the school have legitimately identified as experiencing disadvantage

This details the impact that our pupil premium activity had on pupils in the 2024 to 2025 academic year.

PP eligible pupils in Yr 6 achieved very highly last year with standards above all pupils nationally at the expected standard but below at the higher level in reading and maths. Across the school maths and writing remain the priority especially at greater depth. 35% of our PP children have dual needs and are on the SEND register. 7.5% of our PPG children have an EHCP plan 56% of our PPG children can also be classed as vulnerable (open to SS or other vulnerabilities, eg refugee, parent in prison or have suffered a significant close bereavement) 21% of our PPG children fall into both categories.

Overall, the results show that teaching, support and intervention were successful. We will continue to ensure all year groups continue to make good progress and that individual pupils that have not achieved ARE are provided with a targeted intervention through careful monitoring.

Writing 72% of PPG children are at or above the expected standard.

The percentage of PPG children at ARE in writing is lower than in reading. This will need to remain highlighted as a focus for in class teaching especially in KS1.

We have seen a significant increase in children coming into school who are not school ready and are in receipt of PPG funding. Supporting our youngest most vulnerable children must remain a significant priority. Only 44% of FS2 PPG children achieved a good level of development. All the children who did not have SEN or other significant vulnerabilities.

Communication/ Phonics

This year 75% of the disadvantaged children passed their phonics screening test in 2025 (national 67%), compared with 97% of non-disadvantaged (national 80%). The children who did not pass(2), one has an EHC plan and the other pupil is on the SEND register.

Phonics teaching continues to be a priority for the children now in Year 2 who did not pass with them having small focus group work on phonics as well as 1-1 work.

Attendance

The end of the year attendance data was 94%,(IDSR*) for our FSM children this was 92.3%(IDSR) this is inline with national data.

Obviously, attendance must continue to be a high priority in the 25/26 strategy, with tight procedures rigorously followed as well as support for families to understand the importance of attendance. Term times holiday and parent mental health difficulties remain our biggest challenges for PPG children.
